Preventive and preparatory surface preparation for the reconditioning process of D.M.R. The process is carried out by using a jet of compressed air and bicarbonate with or without water with the effect of removing any contaminant from the surface, allowing to enhance the result of the subsequent stages. This operation is conceptually similar to the manual brushing operation of the DMR, normally performed before they are subjected to subsequent washing, disinfection and / or sterilization processes.

System consisting of a "glove box" type cabin in which it is possible to clean reusable medical devices (DMR), before they are subjected to subsequent washing and sterilization processes. Cleaning takes place by dispensing a jet of bicarbonate, water and compressed air: this process is similar to mechanical brushing with high efficacy and efficiency.
